Accordingly He is appointed as LD Clerk in Police Headquarters,Thiruvananthapuram in the scale of Pay of Rs.19000-43600/-. This appointment will be provisional subject to the provisions contained in Sub Rule 3(c) and Rule 10(b) and sub Rule 9(1) of the General Rule of the KS&SSRs and subject to verification of character and antecedents as contemplated in GO(P) 49/74/PD dated 05.03.1974. He will be on probation for a period of 3 years on duty within a continuous period of three years of service from the date of joining for duty in the department as per the provisions in Rule 10 A of the General Rules.

The appointment will be regularized after verification of his character and antecedents, ascertaining suitability for appointment in Government service and after getting further verification certificate from Kerala Public Service Commission. If anything adverse is noticed during the verification of character and antecedents, his service will be terminated without further notice as per the provisions in GO(MS), No. 191/74/Home dated 29.11.2014.

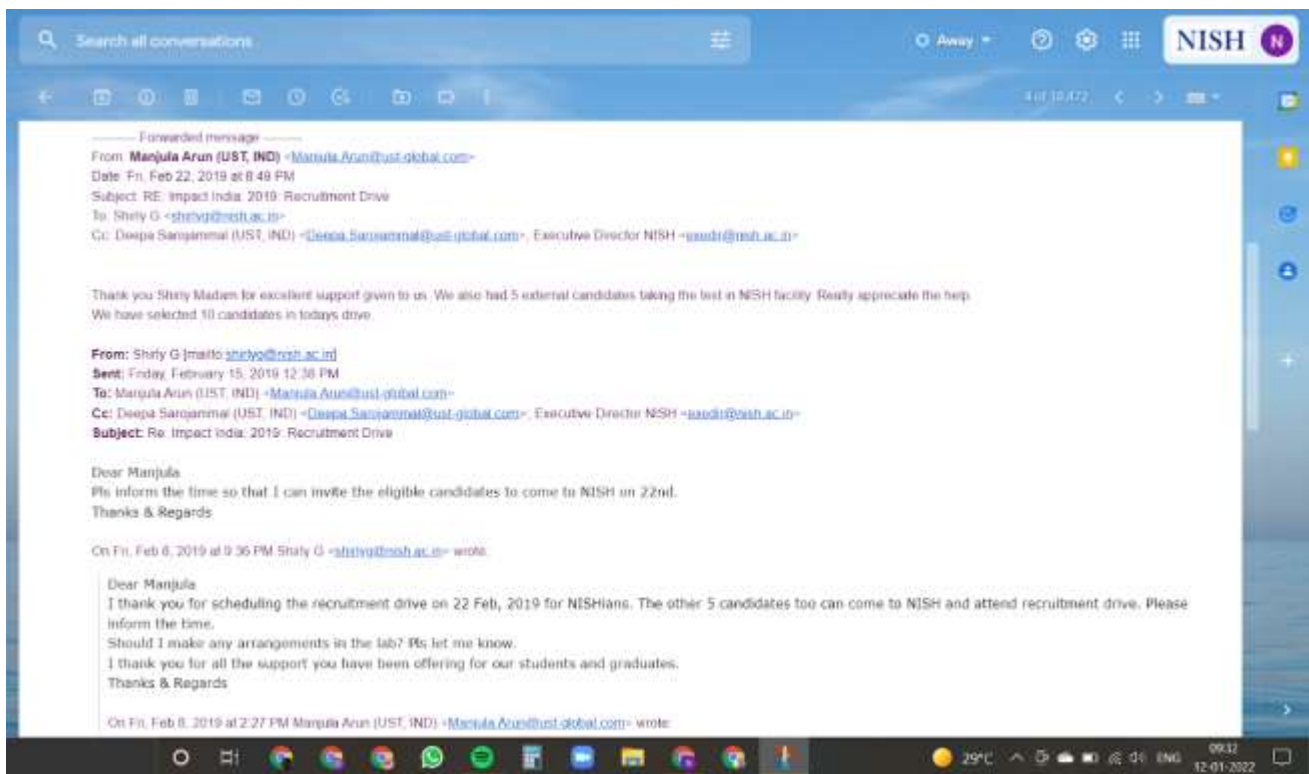
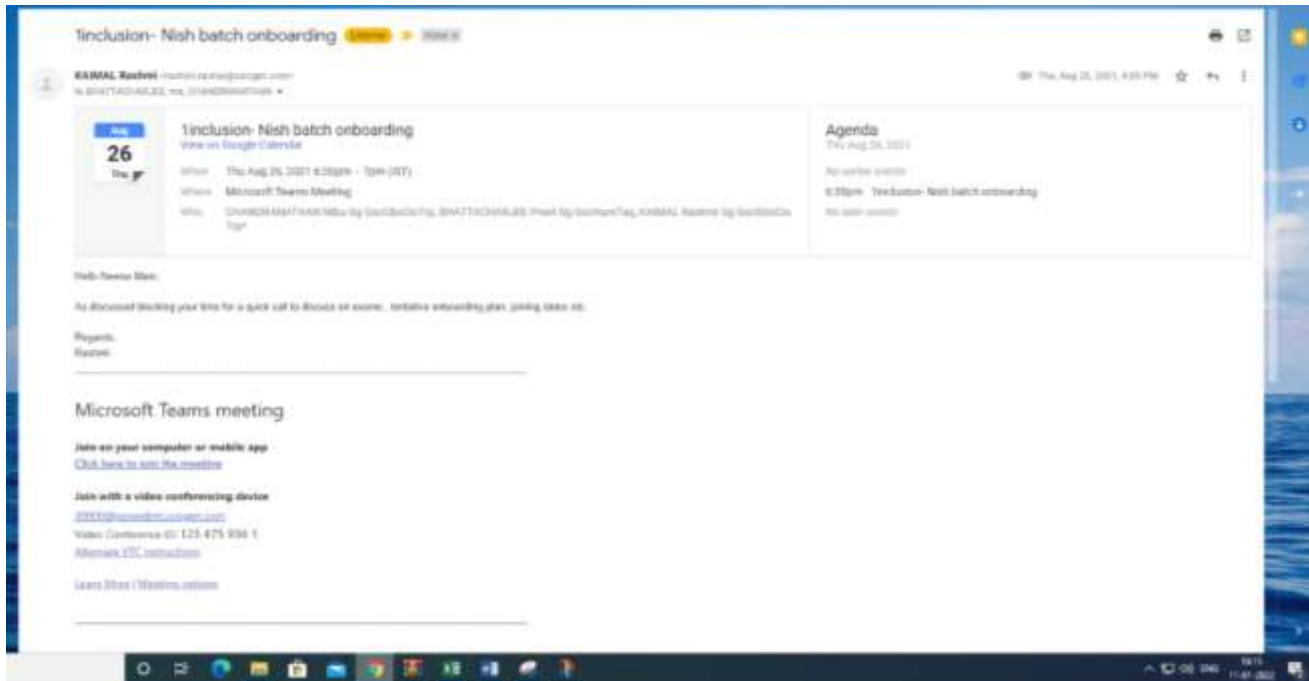
