### **Online Payment**

This online payment system is provided by NISH. NISH may update these terms from time to time and any changes will be effective immediately on being set out here. Please ensure you are aware of the current terms. The country of domicile for NISH is India.

### **Terms & Conditions**

Please read these terms carefully before using the online payment facility. Using the online payment facility on this website indicates that you accept these terms. If you do not accept these terms do not use this facility.

All payments are subject to the following conditions:-

The descriptions of offences are specific to you (i.e. Offence name, Date etc.) when you log in with your unique password. All the fines quoted are in Indian Rupees. NISH reserves the right to change the finest at any time.

- Your payment will normally reach NISH account to which you are making a payment within two working days.
- We cannot accept the liability for a payment not reaching to NISH account due to your quoting on an incorrect account number or incorrect personal details. Neither can we accept the liability if payment is refused or declined by the credit/debit card supplier for any reason.
- If the card supplier declines payment NISH is under no obligation to bring this fact to your attention. You should check with your Bank/Credit/Debit card supplier that payment has been deducted from your account.
- In no event will NISH be liable for any damages whatsoever arising out of the use, inability to use, or the results of use of this site, any websites linked to this site, or the materials or information contained at any or all such sites, whether based on warranty, contract, tort or any other legal theory and whether or not advised of the possibility of such damages.

### **Refund Policy/Cancellation Policy**

All payment details which are entered through this payment gateway are encrypted when the offender, or third party make payment, enters them. Communications to and from the

service provider's website are encrypted.

NISH shall not be liable for any failure by the offender or third party making payment of fine to properly protect data from being seen on their screen by other persons or otherwise obtained by such persons, during the online payment process or in respect of any omission to provide accurate information in the course of the online payment process.

### **Service provider**

Online payments of fines can be made by Credit / Debit card or Netbanking. These payments are not collected by NISH directly but by the service provider.

Once payment is received by the service provider in cleared funds, the service provider will contact NISH to confirm the details of the successful payment made by the offender, or third party making payment. On receipt of this confirmation, NISH will confirm to the offender that the payment has been received and accepted by the NISH. In the event that the offender does not receive confirmation within 14 days of making the payment it is the responsibility of the offender to check with the NISH that the payment has been accepted. The offender shall remain responsible for the fine until such time as the confirmation as referred to above is received from the NISH in relation to each of these and any outstanding amounts owed to the NISH.
